## **1. THE ORGANISATION**

The European Joint Undertaking for ITER and the Development of Fusion Energy ('Fusion for Energy' or F4E) plays a key role in realising fusion as a possible future source of energy by providing the European contributions to the ITER International fusion energy project and the Broader Approach Agreement with Japan as well as by preparing for the construction of a demonstration fusion reactor.

In its role as the Euratom Domestic Agency for ITER, F4E:

- Oversees preparation of the ITER project site in Cadarache, France;
- Provides in kind components, equipment, materials and other resources to ITER;
- Manages procurement arrangements with ITER ;
- Coordinates Euratom's participation in the scientific exploitation of ITER;
- Provides for the implementation of R&D activities in support ITER;
- Provides Euratom's financial contribution to ITER;
- Provides arrangements to make human resources available for ITER.

In its role as the Implementing Agency for the Broader Approach Agreement with Japan, F4E:

- Provides components, equipment and other resources for the Broader Approach (BA);
- Coordinates Euratom's participation in the Broader Approach implementation ;
- Provides for the implementation of associated R&D activities;
- Provides the Euratom financial contribution to the Broader Approach;
- Arranges to make human resources available for the Broader Approach.

In preparation for the construction of a demonstration fusion reactor (DEMO) and related facilities including the International Fusion Materials Irradiation Facility (IFMIF), F4E will implement a programme of research, development and design activities.

## **2. JOB DESCRIPTION - RESPONSIBILITIES**

As a member of the Administration Department of 'Fusion for Energy', and directly reporting to the Head of the Information and Communication Technologies (ICT) Unit, the Datacentre Infrastructure (DI) Services Officer will lead a group of people delivering DI services to the rest of F4E ICT Unit therefore contributing to the delivery of applications and services to the rest of the organization and to external partners.

The ICT Unit in the F4E Administration Department has built a state of the art ICT Infrastructure to offer services to internal and external users. Based on state of the art Private Cloud concept it manages Test, Pre-Production and Production environments based on virtualized architecture.

The Datacentre Infrastructure Services Officer will, under the responsibility of the Head of the ICT Unit, be responsible for the design, implementation and operation of F4E ICT physical and virtual infrastructure, guaranteeing its availability, performance and security.

The successful candidate will, among other tasks:

- Coordinate, manage and develop a team of people assigned to the following areas: Infrastructure Engineering, Network, Internet and Security Services, Storage, Backup and Databases;
- Support the Head of the ICT Unit in the definition of a strategy for the Datacentre Infrastructure Services, including budget definition and execution;
- Ensure the execution of his/her team's assignments in time and with quality;
- Ensure the delivery of services in compliance with the agreed Service Level Agreements;
- Be responsible for the design, implementation, operation and maintenance of:
  - F4E Datacentres;
  - ICT Network Infrastructure;
  - High Availability solutions and services;
  - F4E ICT security solutions;
  - DBMS services;
  - Storage, backup and archiving solutions.
- Assume the role of ICT Security Officer;
- Establish and maintain appropriate systems for monitoring, measuring and reporting on security, operational systems and networks, operational issues, availability and capacity;
- Establish and maintain necessary process, policies and operational documentation;
- Ensure activities meet with and integrate with F4E requirements for quality management, security policies and legal stipulations.

## **3. GENERAL CONDITIONS**

### **A. ELIGIBILITY CRITERIA**

A1. In order to be eligible the candidate must:

- Be a citizen of one of the Member States of the European Union or of a Third state fully associated with the Euratom fusion programme (Switzerland).
- Enjoy his/her full rights as a citizen.<sup>1</sup>
- Have fulfilled the obligations imposed on them by the laws of their home country concerning military service.

<sup>1</sup> Prior to any appointment, the successful candidate will be asked to provide a certificate issued by the competent authority attesting the absence of any criminal record.

- Meet the character requirements for the duties involved.
- Be physically fit to perform their duties<sup>2</sup>.

A2. On the closing date for registration the candidate must possess:

At least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma and, after having obtained the university degree, at least 3 years of proven professional experience;

Only study titles that have been awarded by the Members of the Joint Undertaking or that are subject to the equivalence certificates issued by the authorities in the said Member States shall be taken into consideration.

A3. The candidate must possess a thorough knowledge of one of the official languages of the European Union and a satisfactory knowledge of another language of the European Union to the extent necessary for the performance of his/her duties<sup>3</sup>.

## **B. QUALIFICATIONS AND EXPERIENCE REQUIRED**

### **B1 Essential Selection Criteria**

- University degree in Computer Science or equivalent;
- At least 3 years of proven professional experience in the area of ICT Infrastructure Management and Operations;
- Extended knowledge and experience in at least three of the following:
  - ICT infrastructure design,
  - ICT infrastructure management and operations,
  - ICT systems and ICT technical architecture,
  - Change and release management,
  - ICT Security Policies and Practices;
- Experience of ICT infrastructure technologies and platforms in a distributed environment. Evidence of such experience should refer to at least five of the following:
  - Server Hardware,
  - CISCO networking equipment,
  - VMWare virtualization technologies,
  - DBMS like Oracle DBMS and MS SQL Server,
  - SAN and NAS technologies,
  - VPN technologies,
  - Backup and archiving solutions,
  - Firewalling solutions;
- Experience in successfully managing operational teams in a complex, global organisation;
- Experience in working with third-parties to deliver seamless ICT operations;
- Analysis and problem solving skills;
- Good planning and decision making skills;

<sup>2</sup> Before his/her appointment, the candidate shall be medically examined in line with requirement of Article 12(2)(d) of the Conditions of employment of other servants of the European Communities.

<sup>3</sup> In addition, staff members are required to have a working knowledge of a third EU language, as described in the applicable Staff Regulations and Implementing Rules in order to be considered for their first promotion.

- Good people management skills;
- Good command of both written and spoken English, the working language of the ITER Project.

## B2 Advantageous Selection Criteria

- Knowledge and experience of ISO 20000 norm and ITIL-based service management practices;
- Knowledge of EU Procurement rules;
- Knowledge of CISCO switching and routing technologies like 4500, 6500, NEXUS;
- Knowledge of Juniper Secure Access solutions;
- Knowledge of IBM Tivoli backup technology;
- Knowledge of Videoconference technology and, in particular, Tandberg;
- Knowledge of Antivirus technologies;
- Knowledge of proxy, DNS, e-mail relays technologies;
- Knowledge of PKI infrastructures;
- Knowledge of MS Windows Server 2008 R2 and MS ForeFront TMG;
- Knowledge of Linux operating system;
- Working experience in a European or international setting.

## 4. CONDITIONS OF EMPLOYMENT

A contract offer will be made as a member of temporary staff, pursuant to Article 2(a) of the Conditions of Employment of other servants of the European Communities.

The successful candidate will be recruited in the grade AD6 on a contract with an initial duration of five years, with possibility of renewal.

The salaries of temporary agents are subject to a community tax deducted at source. They are exempt from national tax. The European institutions have their own social security and pension scheme. **As an indication, the basic monthly salary, before any deductions or allowances, for grade AD6 (step 1) is currently 4.921,28€.**

In addition to the basic salary, staff members may be entitled to various allowances, in particular a household allowance, expatriation allowance (16% of basic salary and household allowance), dependent child allowance and education allowance. The salary is subject to a reasonable Community tax deducted at source and staff members are exempt of national taxation.

Under certain circumstances, in particular where the jobholder is obliged to change his/her place of residence in order to take up employment, 'Fusion for Energy' may also reimburse various expenses incurred on recruitment, notably removal expenses.

The place of employment is **Barcelona, Spain.**

Given the needs of the organisation, the candidate may be offered an employment at any of the other F4E working places: Garching (Germany) or Cadarache (France).

For reasons related to the 'Fusion for Energy' operational requirements, the candidate will be required to be available at short notice.

## 5. SELECTION PROCEDURE

A Selection Committee will be set up for the selection process. The eligibility of candidates will be assessed by the Committee according to compliance with all formal requirements by the closing date for the submission of applications. Any applications which do not meet the requirements specified in a

vacancy notice (i.e. incomplete applications, applications submitted after the deadline or which do not meet the detailed criteria listed under 'the eligibility criteria') will be rejected.

Eligible candidates who meet all essential selection criteria and have the best profiles for the specific needs will be invited for an interview, which will be held mainly in English. The interview might include one or more live tests related to the nature of the duties, more information will be provided in the invitation letter. Candidates invited for an interview will be requested to present for verification all documents supporting every educational achievement and work experience they have referred to in the application.

The interview will focus in particular on the candidate's specialist knowledge in the field of the selection and his/her knowledge of the main developments in European integration and Community policies. The interview is also designed to evaluate his/her linguistic skills and ability to adjust to working in a multicultural environment.

The interview sessions will be held in **Barcelona, Spain**.

**Please note that the Selection Committee's work and deliberations are strictly confidential and that any contact with its members is strictly forbidden.**

After the interviews, the Selection Committee will draw up a reserve list with the most suitable candidates, which will be adopted by the Appointing Authority and will be valid until 31 December 2013 and may be extended. As soon as this decision is taken, successful candidates will be informed. However, candidates should note that inclusion in the reserve list does not guarantee recruitment.

Please note that a binding commitment can only be made after verification of all conditions and will take form of a contract signed by the Director of 'Fusion for Energy', on proposal by the Selection Committee. If at any stage of the procedure it is established that any of the information a candidate provided is incorrect, this candidate will be disqualified.

The present vacancy notice is subject to the availability of budget and posts in the establishment plan of the Joint Undertaking, as decided by the EU budgetary authority.

## **6. GENERAL INFORMATION**

### **Commitment to promote equal opportunities**

'Fusion for Energy' is an equal opportunities employer and strongly encourages applications from all candidates who fulfil the eligibility and selection criteria without any distinction whatsoever on grounds of nationality, age, race, political, philosophical or religious conviction, gender or sexual orientation and regardless of disabilities, marital status or other family situation.
